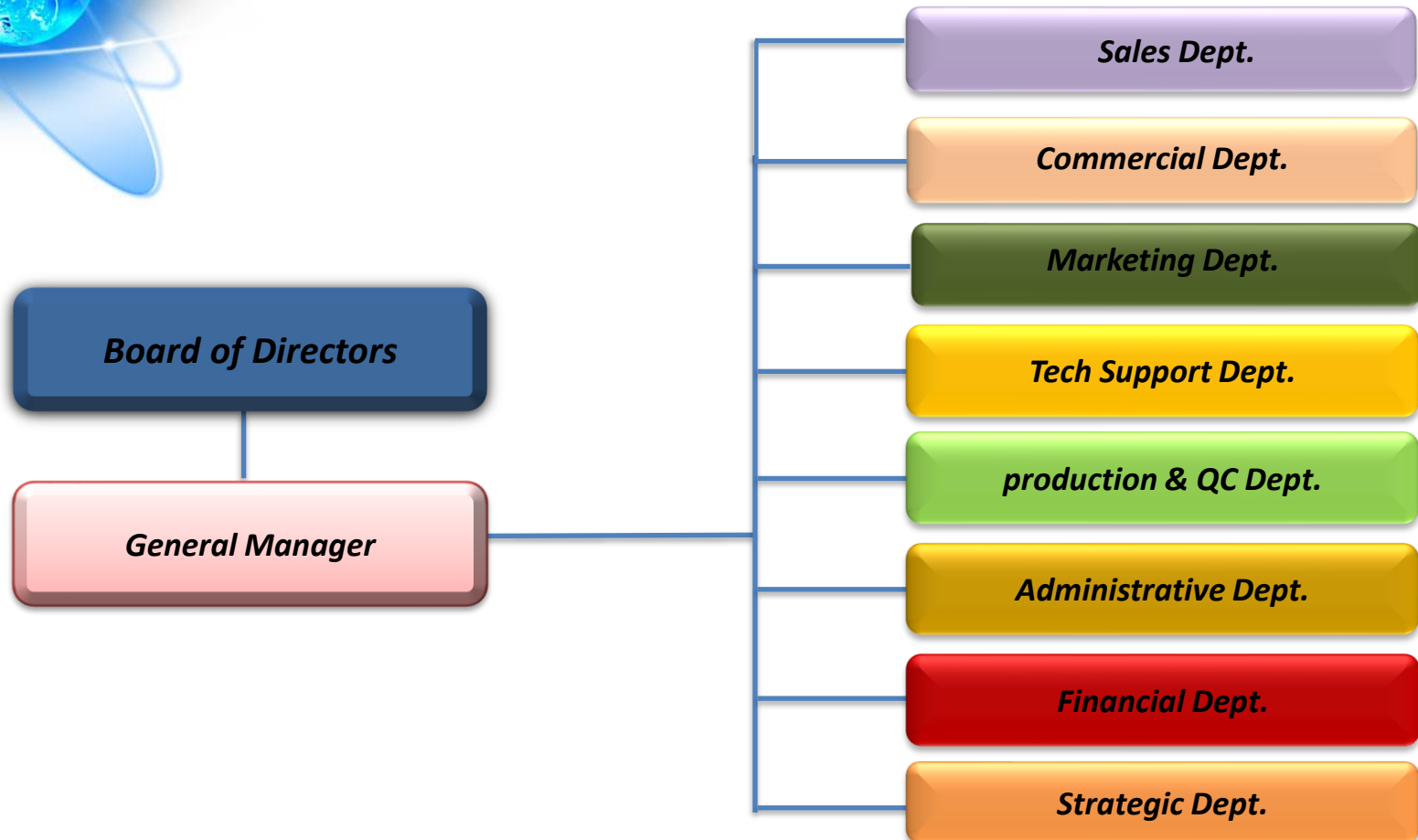

Organization Chart

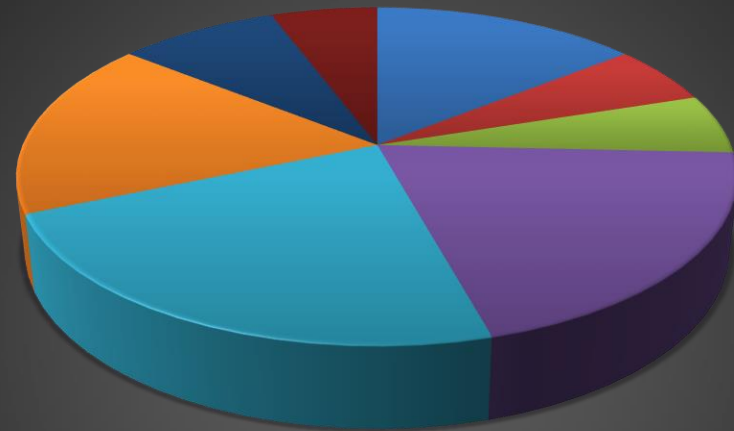

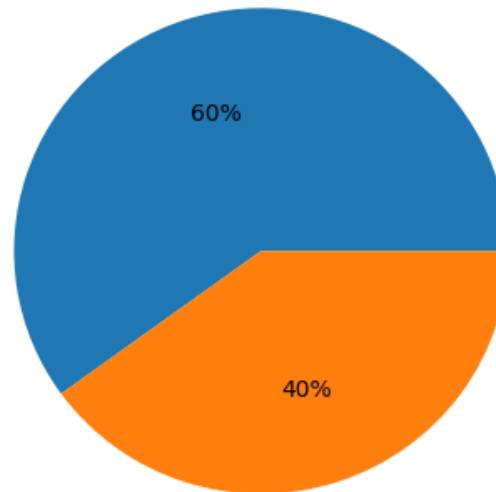
